**ALCOHOL & TOBACCO RULE**

From 2010 forward, the NKSL has mandated the following alcohol and tobacco rule to be followed by all teams that are members of the NKSL:

**Alcohol & Tobacco Rule:** During swim and dive meets no athlete, coach, or worker is permitted to use or consume alcohol products while they are, or plan to be, engaged in the operation of the meet. The use of tobacco products is prohibited by all athletes, coaches, or workers if they are engaged in the operation of the meet, and use maybe further restricted based on restrictions imposed by individual clubs. Should a parent, coach, coworker, or athlete suspect this rule is being violated, they should raise the issue to their NKSL Delegate for resolution.

The NKSL is a summer, recreational swim league for our children. Adults and family members need to be responsible while in the care of their children and other children during swim meets. If you are not working the meet, we are not encouraging your consumption of alcohol or smoking, but we ask that you use utmost discretion. Cherry Hill Swim & Dive Club Boosters, Inc., are requiring all parents or family members of legal age who, in any way, will participate in our meets sign the below statement indicating that they have read the above statement. Your children and the Boosters thank you for your support.
