<u>To work as a</u>	<u>You must be at least</u>
Coach.....	18 years old by May 25, 2010
Lifeguard.....	currently certified by Red Cross
Concession Staff...	14 years old by March 1, 2010

And you must meet the following criteria:

#### Lifeguard Candidates:

- ✓ Lifeguards candidates must have Red Cross Lifeguard Certification prior to May 15, 2010.
- ✓ Lifeguards should have availability to prepare pool during one weekend in May and help to close the pool in September.
- ✓ Employment as a lifeguard is contingent upon the successful completion of a **Water Skills Test**.
- ✓ Lifeguards must work a minimum of 10 hours per week, maximum of 40 hours per week.

#### Concessions/Front Desk Staff:

- ✓ Ability to effectively communicate with the public and staff and work harmoniously with people in an enthusiastic manner.
- ✓ Handles money transactions accurately.
- ✓ Can multi-task.
- ✓ Possess pleasant telephone etiquette.
